BYLAWS UPDATE

Last year in 2019 we formed a committee for updating our Articles of Incorporation and our Bylaws. The Articles were changed in approved last fall and voted on. This year we finished up the Bylaw changes and presented them for approval by the board. Below are the changes made in bold. If you would like a copy of the entire Bylaws, please let me know and I will email to you. We are presenting them to you now. They will be voted on by membership at the annual meeting 2021.

RESTATED BYLAWS OF BELOIT RIFLE CLUB, INC.

(Affiliate of the National Rifle Association of America)

ARTICLE II Members, Voting Rights and Dues

2.4 <u>Determination of Membership Dues</u>. All members of the Corporation shall pay annual dues (excludes current active life members). The amount of such dues shall be determined at the 1st general meeting of the year by the board of directors and shall be based on the operating expenses of the Corporation during the preceding year.

ARTICLE III Meetings

- 3.3 Special Meetings. Special meetings of the members may be called by the President, the Board of Directors or by demand in writing **by a member,** stating the object of the proposed meeting, and signed by five ten percent (5% 10%) of the members entitled to vote.
- 3.4 <u>Place of Meetings</u>. Meetings of the members may be held at any place within **Rock County**, Wisconsin. such action. Such action by written consent shall have the same force and effect as the unanimous vote of the members.
- 3.8 Quorum; Action. One twentieth (1/20) Ten percent (10%) of the number of members shall constitute a quorum for the transaction of business. Every act or decision done or made by a majority of the members present at a duly held meeting at which a quorum is present shall be the act or decision of the members, unless the law, the Articles of Incorporation of the Corporation or these Bylaws require a greater proportion.
- (c). Any applicant or member with a Felony, who can not legally own a firearm, can not be a member. Any member who is under felony inditement will have their

membership suspended until final hearing within the Justice System.

ARTICLE IV Directors

4.2 Number; Election; Term.

- (a). The number of Directors of this Corporation shall be Thirty (30) or such number as may be designated from time to time by the Board of Directors, but no less than three (3). Except as otherwise provided herein with respect to the terms of the initial Directors, each Director shall hold office for a term of one (1) year or until such Director's successor shall have been duly elected or until such Director's death, resignation or removal, except the Rules committee which shall be composed of four (4) members. One member shall be elected each year for a three (3) year term and shall be the number three (3) members of the committee, the other members to move up one slot. The member at the top of the list shall be the chairman. The number (4) member of the committee shall always be the Past President and will not change position. Directors may be re-elected to serve more than one term in office.
- (d). A Nominating Committee shall consist of three (3) members, two (2) appointed by the President with the Vice President acting as chairman of this committee. This committee shall name at least one person for each of the four (4) officers and the members for each of the disciplines, with space provided below each name for write-in's during the election. nominations from the floor. The Nominating Committee shall remain active for one (1) year or until a new Nominating Committee is appointed, and shall provide names for director approval to fill vacancies.
- (e) In the event a person wants to be nominated but can not be present the night of elections, that person can be nominated by petitions. The petition shall be signed by fifteen (15) members in good standing, showing the name, address and membership eard number and be delivered to the election steward three (3) days before the election. The petition shall also show what office or committee the person is interested in. There will be no nominations from the floor unless position has no nominees at time of election. must have prior approval.

ARTICLE VI Match Rules

(a) All rifle and revolver or pistol competitions held by the Corporation shall be governed by the rules and regulations laid down by the National Rifle Association of America,

approved by the National Board for the Promotion of Rifle Practice and the Secretary of the Army.

6.1 Any and all firearms competitions help by the corporation must be approved by the Board of Directors and/or governed by the rules and regulations laid down by the national ruling body of the discipline conducting the competition.

ARTICLE VIII Miscellaneous

(b). Remaining assets shall be distributed to the National Rifle Association or any successor qualifying under Section 501(e)(4) 501(c)(7) of the Internal Revenue Code or its successor provision.

ARTICLE XIV <u>Life Membership Qualification and Procedure</u>

- A. Person sponsoring a candidate for Life Membership shall fill out an application and present the application to the rules committee and be present, at the time of application submission, for an interview with the rules committee. Applications are available from any Rules Committee member; check your membership card for member's names.
- B. Must have been a member of the Beloit Rifle Club for 15 consecutive years and it is recommended that the member also be a Life Member of the National Rifle Association. Sponsoring person must also be a member of the Beloit Rifle Club for at least 15 years.
- C. Must have been a member of the board of Directors of the club for at least 3 of those years, if on the executive portion of the board, or 5 of those years as a discipline/assistant director. Applications must be turned into Rules Committee on / or before October 1.
- D. During those 15 continuous years, the individual must have made a significant contribution to the club. That contribution can be in the form of facility development, generation of a revenue stream to help the club support the area of their discipline, any major improvement to their discipline that enhances the value of the club, or in other words, a significant contribution.
- E. The rules committee will review all applications, interview sponsors and vote as to if qualifications have been met. They will make up a list of approved candidates for Board approval. The committee will also create and forward a letter to those sponsors who have submitted candidates who have not met the qualification standards and will indicate why they have not met them.
 - F. Applications and sponsor interviews must be

completed before the December meeting where the candidates will be listed for the Board to vote. There will be a maximum of two (2) awarded each year. This is a maximum not a requirement. Life Membership is not to exceed 2.5% of the total membership, or a maximum of 25.

G. Applications are available from the Rules and/or Membership committee.

BENEFITS

A life Member of the Beloit Rifle Club shall:

- A. Be excused from the work hours,
- B. Be excused from paying the annual amount of dues,
- C. Shall have all of the rights of regular dues paying members,
- D. Shall continue with these benefits until death or relocating to an area where their ability to attend club meeting and functions becomes a logistic inconvenience,
- E. Be encouraged to attend meetings and activities as health permits,
- F. Be willing, as health permits, to assist the Club in projects where their past expertise has aided the completion of a project.

New Standard Operating Rules For 500 Meter Range

- 1. Red Badge Certified Members Only. Red Badge must be worn.
- 2. All Shooters must sign in prior to shooting. (A sign-in sheet will be in the shed next to the guest sign-in sheet. Sign in with date, name, time in/out.)
- 3. All shooting to be done from the bench top only. (No prone or standing are allowed.)
- 4. No hand guns allowed. Only rifles or bolt-action pistols.
- 5. Every time prior to using 200/300/500m range, rifle and ammunition must be sighted in at 100 yards. A 5 shot 3 inch group must be held to move to 200/300/500m distances.
- 6. Minimum muzzle velocity must exceed 2300 ft per second. If in doubt do not shoot until you can get chronographed.
- 7. Only BRC provided steel targets allowed.
- 8. When 'cease fire' is called, properly display Hot/Cold sign with warning light. "Cold" means it is safe to go down range. Warning lights to be on when range is cold. "Hot" means the range is active. Do not go forward of the firing line.
- 9. No handling of firearms when range is Cold.
- 10. All firearms must be racked or cased & off the firing line with bolts open or chamber indicated and magazines removed when range is Cold.
- 11. Benchrest, BR-50, CMP and Highpower disciplines have control of the entire firing line during their matches. All lanes will be closed to non-participants at that time.

500 Meter Range

The 500 Meter Range consists of 18 shooting benches, the first 12 are for general use by all members and their guests. The benches are numbered 1 thru 18 from left to right.

BENCHES 13 THRU 18 ARE POSITIONED FOR USE OUT TO 500 METERS AND ARE ONLY TO BE USED BY THOSE BRC MEMBERS

WHO HAVE GONE THROUGH THE QUALIFICATION PROCESS FOR THAT RANGE. NO GUEST IS ALLOWED TO USE THIS PORTION OF THE RANGE.

The qualification process is posted in the club house and on the bulletin board at the 500 meter range. That process is:

- 1. Shoot a 3 shot group a 100 yards to verify rifle zero.
- 2. Obtain bullet weight and velocity.
- 3. Calculate the necessary sight change to impact at 500 meters (547 yards).
- 4. Prove proper sight adjustment from calculations in step "3" by shooting another 3 shot group at 100 yards with the calculated adjustments made to your sights. The group should be 9 inches to 17 inches high depending on bullet speed and weight.
- 5. After the rifle is properly adjusted to strike high at 100 yards, the shooter to be qualified must fire 4 shots at 500 meters; all shots must strike within a 20 inch square steel plate. More than 4 shots are allowed as needed.
- 6. Upon completion of the above orientation, the member's name and \$5.00 processing fee, will be forwarded to Jon Nortemann. A special "RED 500 Meter" badge, with the members name will be made for the member to wear. The member will also have his/her membership card signed to substitute for the badge until it arrives.

THE 500 METER RANGE IS FOR QUALIFIED BRC MEMBERS

ONLY! NO GUESTS! We have over 250 members qualified. Before members may use the shorter range target boards, 200 meters, 300 meters and steel targets, which co-exist on the 500 Meter Range, they MUST BE QUALIFIED AT 500 METERS. Guests are not allowed to use the shorter ranges on the 500 Meter Range at any time. NOTE: ONLY QUALIFIED BRC MEMBERS ARE ALLOWED TO USE THE 500 METER RANGE, BENCH POSI-**TIONS 13 THRU 18 REGARDLESS** OF THE RANGES AT WHICH BACKSTOPS AND TARGET **BOARDS ARE INSTALLED.**

I will be qualifying members to use the 500 meter range on any Wednesday morning that the 'Wednesday Morning Group' shoots, between 9:00 AM and noon. You may call the other 9 members to set up other times if needed.

If you are shooting a caliber that is damaging our steel targets and/or range facilities, PLEASE STOP. This club belongs to each BRC member and needs to be treated with respect. Normal wear and tear is expected but should not be accelerated. Thank-you.

Remember: These Are Rules

- 1. No unintended discharge of a firearm.
- 2. No rounds to leave the range.
- 3. Wear your safety glasses and hearing protection.
- 4. ALL members, whether new this year or a 40 year plus veteran have a duty to see that our rules and procedures are followed. Politely remind each other if infractions are observed. We have a "jewel" of a club. Please keep it that way. THANK YOU!
- 5. No 50 BMG's to be used on Club grounds at any time!
- 6. Always wear your Membership Badge.

To pay your dues by mail, please submit the following: Failure to do so could result in loss of membership:

- 1. 2020 Membership Card (with credited hours).
- **2. Range/Padlock Key** Tape your key to your membership card. Lost keys are \$5.00
- 3. Photocopy Of Your Current NRA Membership Status, (Mailing label from your magazine has all this information, just clip and send) *Not required for Life Members*
- **4. Dues Payment** (Check/Money Order Only NO CASH!)
- **5. \$5.00 Mail-in Handling FEE** (just add to your dues payment membership will NOT be processed without this)

REMINDER: When mailing, your range/padlock key <u>will</u> <u>need to be taped securely</u>, to your BRC membership card. Your NRA membership status and payment are also required. A new BRC membership card and new key will be mailed to you. Your checks will be cashed after Feb. 7, 2021. Include your E-mail address if you want confirmation that your check has been received.

If above conditions are not met, your membership will not be processed. This option should be exercised only as a last resort.
